- A copy of student's bank statement from the last 60 days and an affidavit of support (in English) showing student has sufficient funds for the first year of study in the United States.
• For students with a sponsor, UMW requires a letter from the sponsor's bank and an affidavit of support (in English) showing the sponsor has sufficient funds for the first year of student's study in the United States.
• If outside the United States, a student must have a copy of the affidavit and bank statements available for the U.S. Consular when applying for a visa.
