- For students with a sponsor, UMW requires a letter from the sponsor's bank and an affidavit of support (in English) showing the sponsor has sufficient funds for the first year of student's study in the United States. The sponsor must complete and sign the Affidavit of Support.
- If outside the United States, a student must have a copy of the affidavit and bank statements available for the U.S. Consular when applying for a visa.
