



2013-2014 Federal Direct PLUS Request Form

The Federal Direct PLUS Program is intended for 1) an eligible parent to borrow federal funds on behalf of a son or daughter who is a dependent undergraduate student or 2) a graduate/professional student. Awarded funds are intended to assist with payment of the student's educational expenses and are borrowed from the U.S. Department of Education. The person who is applying to be a Federal Direct PLUS Loan borrower must complete this form.

Students must have a valid Free Application for Federal Student Aid (FAFSA) and a completed federal PLUS loan application before the school will process Direct Parent Plus Loans.
